## Rulemaking Summary

For Oregon Public Service Retirement Plan (OPSRP) members, upon retirement PERS calculates an employee's final average salary. PERS will use one of the following as your monthly final average salary, whichever is greater:

- Your average gross salary\*\* or adjusted total gross earned over three consecutive years in which you earned the largest total salary from one or more PERS-participating employers, even if one of those years was less than a full calendar year.

**OR**

- Your total gross salary or adjusted total gross earned over the last 36 months in which you worked in a PERS-qualifying position, divided by the actual number of calendar months of active service within that 36-month period.

Additionally, the final average salary includes any amount of overtime that does not exceed the average number of overtime for the same class and geographic placement of state employees. Under the provisions of ORS 238A.130(4) the Oregon Department of Administrative Services shall establish by rule more than one overtime average for a class of state employees based on the geographic placement of the employees.

The PERS OT Cap rules advisory committee will define "class of state employees" and "geographic placement." The committee will also define the frequency and timeframe from which DAS will determine the average overtime hours.

*\*This is an estimated schedule.*

*\*\*Gross salary is what you earn before taxes and other deductions are taken out.*
