A description of the steps the program has taken to decrease the use of restraint and involuntary seclusion.	• Team has had coaching tailored to behaviors from specific clients from certified Nonviolent Crisis Intervention instructors about specific clients with problem behaviors such as biting and elopement. • Increased verbal problem solving with clients before asking them to leave the classroom • Very thorough debriefs – which changed the teams interventions the next day • Changed classroom placements when it was apparent that a different classroom would be a better fit.
