A description of the steps the program has taken to decrease the use of restraint and involuntary seclusion.	• During each incident there are additional staff to observe and coach the staff to reduce restraint time and use. • Following each incident, the clinical team will discuss interventions used and less restrictive and or different interventions to support the client in the future. • With each client, the team will utilize a trauma informed debrief that consists of Collaborative Problem Solving with the client to understand how to better them when escalated. • Implemented zones of regulation that will aid in catching the deregulation and promote use of coping skills • In the last quarter we have also had special trainings for staff, including behavioral training from a practicing psychologist (November) and milieu management training (October) • Ongoing Nonviolent Crisis Intervention Training is provided to support problem solving and skills practice, including verbal de-escalation and increasing use of Collaborative Problem Solving
