The child is given Cue's and opportunities to take a time out, a break on their own, they can talk with their counselor if they choose. After a restraint or seclusion, when the child is in a good head space we discuss what worked and what did not work for them. Make any adjustments that need to be made in their current plan. We also debrief with the entire staff to see what they observed and any suggestions or insights they may have to improve the chances of not going into a restraint or seclusion.
