A description of the steps the program has taken to decrease the use of restraint and involuntary seclusion.	1) Debrief incident with a multidisciplinary team to get feedback and problem solve a) Plan for learning was developed with teachers to increase processing time and decrease learning stressors for student. 2) Team discussed the client's triggers and warning signs to better provide support to prevent escalation. 3) Trauma informed care principles were discussed during debrief of incidents.
