Staff will reach out to Family to inquire as to thoughts behind what might be catalyst, if any, to behaviors. Staff plan to follow up with family via phone to address youths concerns with length of bus ride. Improving communication between staff when youth is returning to the group after similar incidents and having a plan for how to manage reactionary aggression upon re-introduction.
