A description of the steps the program has taken to decrease the use of restraint and involuntary seclusion.	Because the Nest serves our state's most vulnerable and difficult-to-place kids ages 4-10 with significant trauma histories and challenging behaviors, it is a priority to ensure that any use of physical intervention is appropriate and necessary. This begins with training all staff to understand that "restraint," which at the Nest is therapeutic and calm holding, is always a last resort to be utilized only when other interventions have been unsuccessful, or when someone is in immediate danger. During this quarter, the holds among foster clients were 1 and 2 minute long, with a 6 minutes follow up hold in one of the two instances. In additional to annual Nonviolent Crisis Intervention training, the Nest program also employs two CPI-certified trainers to provide ongoing coaching and support to Nest staff. The program also complies with all applicable oversight and reporting requirements. The Nest Program Director reviews all incidents involving holds; Staff debrief all holds within 48 hours; The program conducts physical restraint reviews when a restraint is used more than twice in a 7-day period; The program submits IR information to DHS and other required parties on an ongoing basis; and BGA submits monthly IR data to DHS for review. Restraints and seclusion are not used at the Neighborhood or STEP.
