All staff are trained and certified in CPI which places an emphasis on verbal de-escalation and avoiding using physical restraint whenever possible. Staff are also trained in and apply CPS. Staff discuss and implement strategies to support clients and their emotional and behavioral needs on an ongoing basis. Clients are taught coping skills, the program has multiple areas for clients to choose to go to in which to take a break/regulate emotionally. Some clients may be put on a reduced day and/or have the support of a 1:1 aide to promote success and gradually build up to a longer treatment day as skills are learned and self-regulation increases.
