## **APD-IM-23-045 Ending Mask Requirements for In-home, CBC, and NF care settings**

---

- AAA Types: A and B
- April 3, 2023, Oregon Health Authority lifted the requirement to wear masks at health care settings, including in-home, CBC and NF care settings.
- Case managers are not required to wear masks during assessments, unless:
  - Consumer requests that a mask be worn or,
  - Case manager chooses to wear a mask.

## **APD-IM-23-046 OR PTC DCI – Hard Stop for Over Hours Entries**

---

- AAA Types: A and B who use HCWs
- Upcoming changes beginning June 2, 2023
- Entries that are over the authorized hours will automatically be rejected at clock-out. Providers will need to adjust their time to be within their authorized hours.
- Auto-approval will only run once per day at 4am.



## APD-IM-23-047 PTC – Flex Lists in OR PTC DCI

---

- AAA Types: A and B who use HCWs
- Upcoming changes beginning June 2, 2023
- Flex lists are used for managing cases with multiple providers and varying hours.
- This is not common for OPI cases.

## **Assessment Training (Four-Part) Series**
