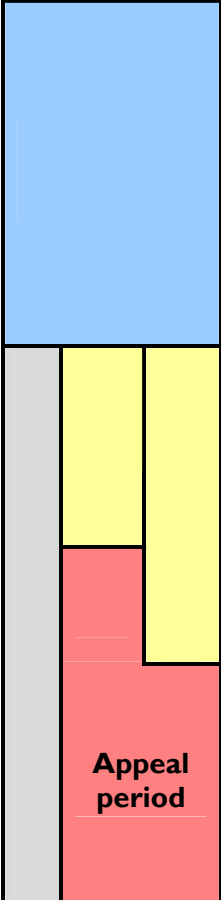

|                                                                                    | c) ODOT notifies an applicant within 30 days if additional information is needed to complete the application. An applicant has up to 60 days to provide the requested information. The 30 days does not include the time an applicant has to provide additional information. |

ODOT must approve the approach design and construction plans and issue a <i>Permit to Construct</i> before an applicant starts construction.</li> <li>2. ODOT sends construction specifications and maintenance requirements to the applicant.</li> <li>3. An applicant has up to 60 days to: 1) accept the construction specifications; and 2) provide proof of construction liability insurance and bond.</li> <li>4. ODOT issues a <i>Permit to Construct</i> the approved approach.</li> </ol> |
