Certification and Stamp Approval Application FAQs

Q: Where can I find provider information on Oregon's Yellow Fever Program?

A: On OHA's [Oregon Yellow Fever Program Information](#) webpage.

Q: As a new applicant, how do I become certified for yellow fever vaccination in Oregon?

A: Fill out our [Application for Oregon Yellow Fever \(YF\) Vaccine Certification and Stamp](#) form.

Q: How long does it take to process my application?

A: About seven to 14 business days. You will receive an email confirmation of your application status.

Q: As a new applicant, do I need to complete the CDC course, *Yellow Fever Vaccine: Information for Health Care Professionals Advising Travelers*?

A: Yes, the [Yellow Fever Vaccine: Information for Health Care Professionals Advising Travelers course](#) is required.

You must then submit the course completion certificate with your application. If you are applying for recertification, you must also submit this course completion certificate with your application. If you do not have a completion certificate, you will need to take or retake the course.

Q: After my application is approved, how do I get a yellow fever stamp?

A: As of May 21, 2026, OHA no longer provides these stamps to providers as part of their certification approval. You can purchase custom stamps online or at local office supply stores. Be sure to provide specific stamp specifications to the vendor. Stamp specifications provide all necessary information for international recognition and verification of yellow fever vaccination.

Q: How much does a stamp cost?

A: You can expect to pay anywhere between \$10 and \$30, but it depends on the retailer.

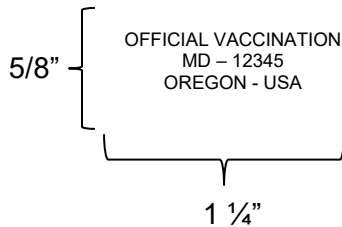
Q: What are the specifications of a uniform stamp for this purpose?

A: When ordering your stamp, make sure all of the words on the stamp fit into a rectangular

shape no taller than 5/8", and no wider than 1-1/4". The text on the stamp must include the following information:

- The phrase "OFFICIAL VACCINATION"
- Administrrating provider's medical license number
- Issuing state or county jurisdiction

Q: What should I do if I misplaced or lost my yellow fever stamp?

A: Reorder a stamp from your preferred vendor.

Q: What do I do if I retire or stop providing the yellow fever vaccine?

A: Notify the Oregon Immunization Program by emailing yellowfever.vaccine@odhsoha.oregon.gov and destroy your stamp.

Q: Can I administer yellow fever vaccination at multiple administration sites in Oregon?

A: Yes. You can register up to three yellow fever vaccination administration sites. If you need to register more than three sites, please email yellowfever.vaccine@odhsoha.oregon.gov.

Only registered sites are eligible to receive yellow fever vaccine and supplies; vaccine and supplies cannot be transferred between sites. You can purchase one stamp for every registered location or you can carry one stamp between locations.

Q: What do I need to do if I change my yellow fever administration site?

Q: It's been three years since I've been approved. How do I recertify?
