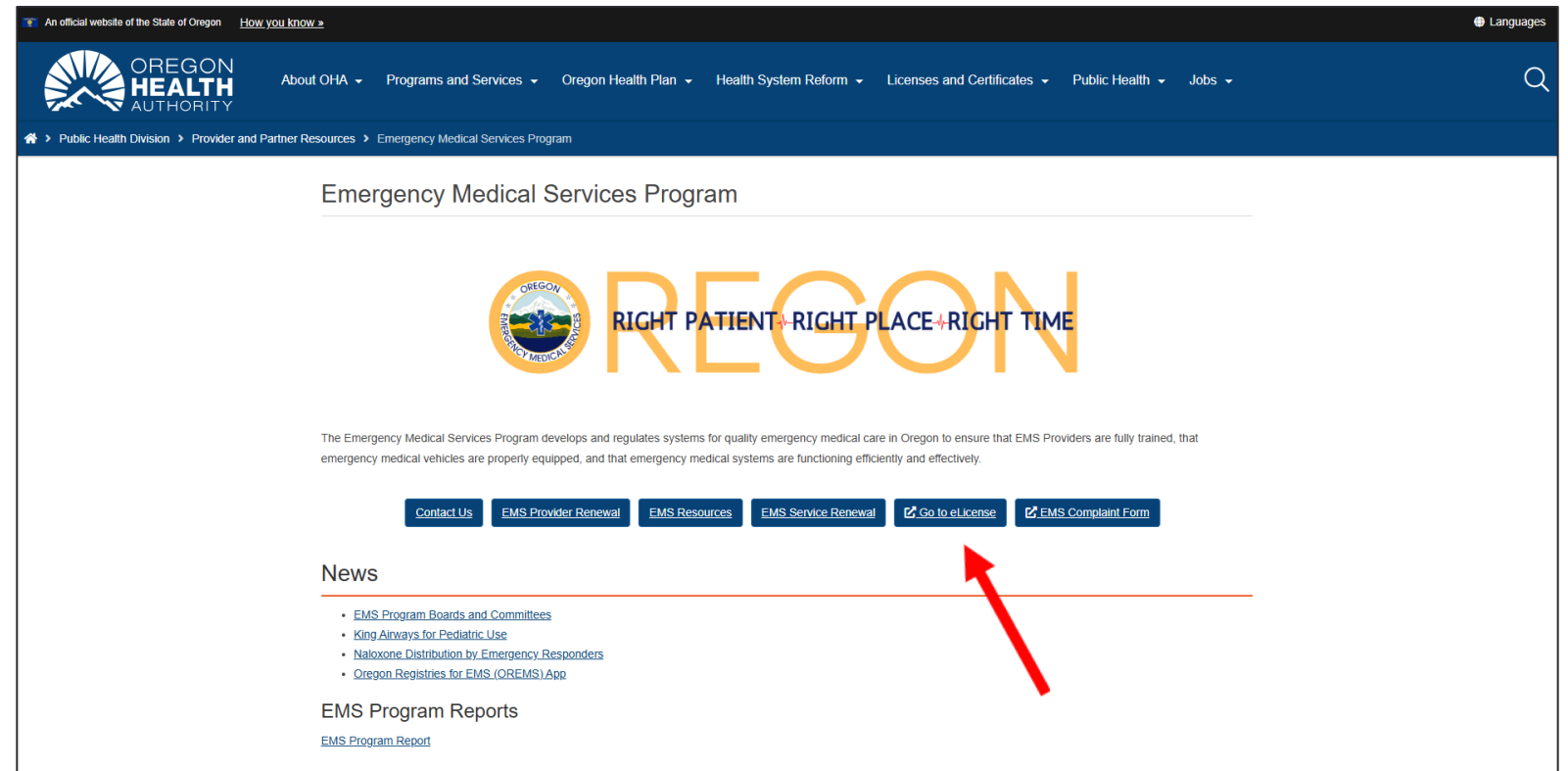

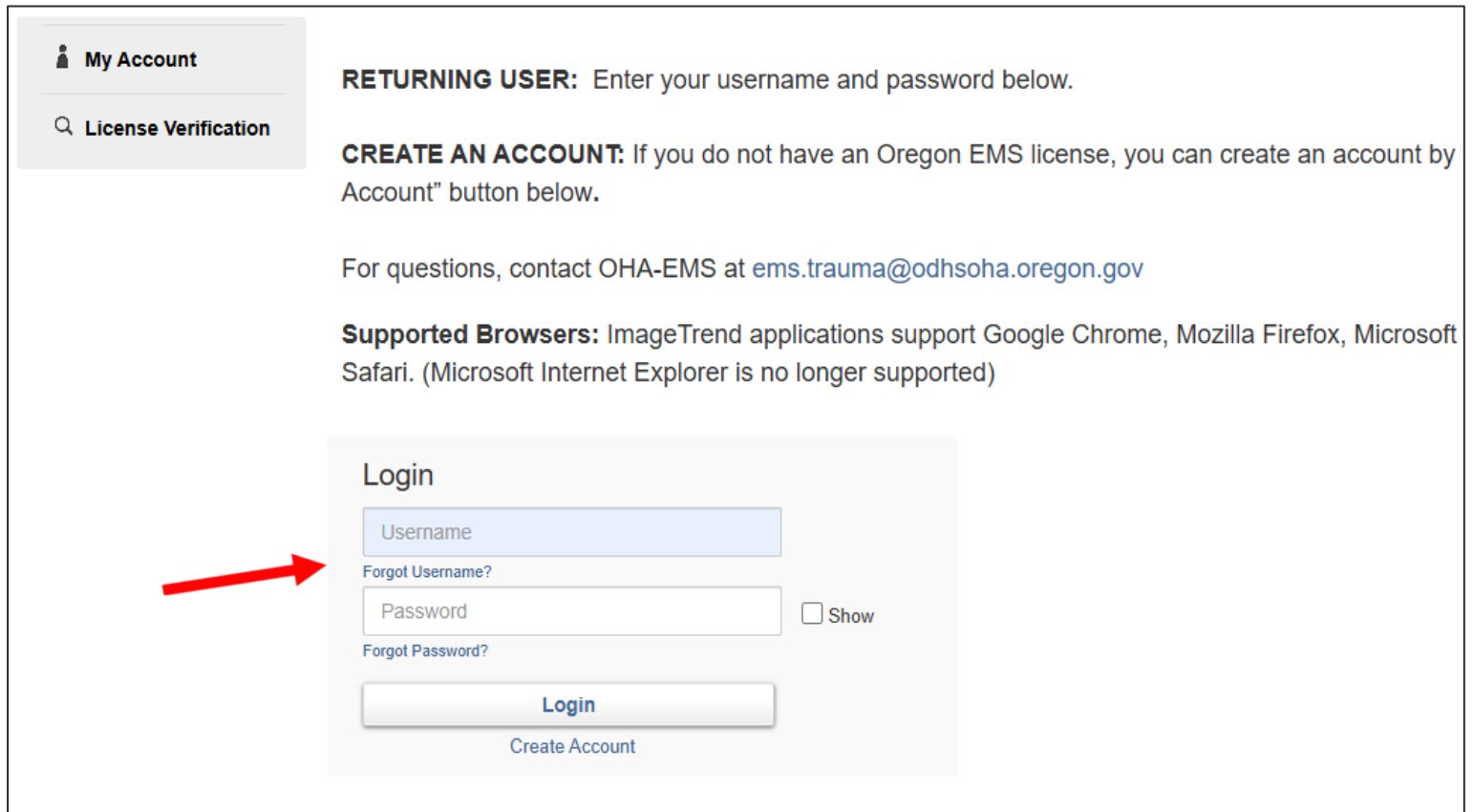

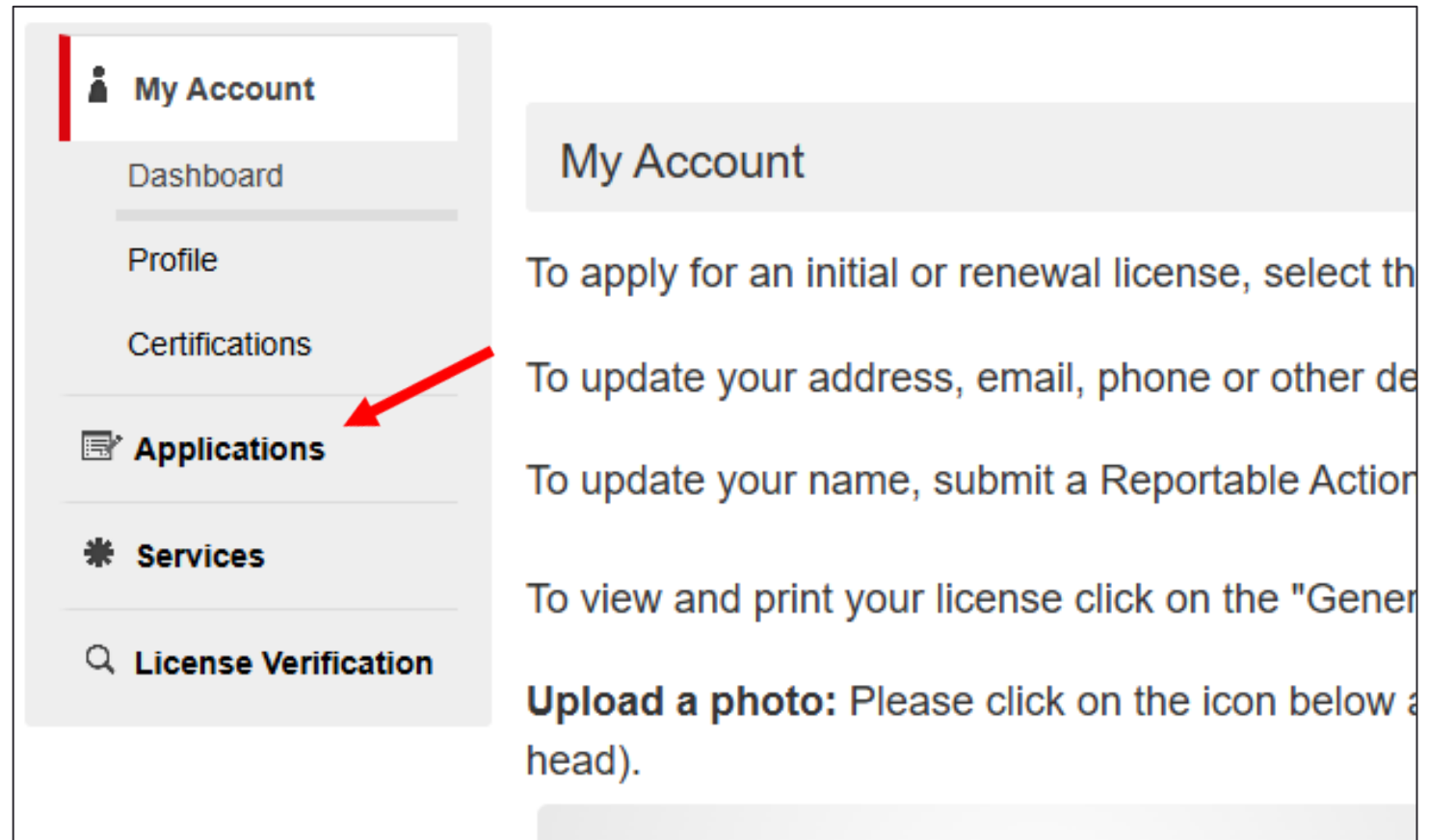

EMS Provider Renewal Instructions

Applications submitted in **late June** are subject to not being processed by July 1st.

If your application is not processed by July 1st, your license will expire. Submitted applications will be processed, please do not apply for reinstatement.

EMS providers are NOT permitted to utilize an EMS license that falls into an expired status. Providers must refrain from working or volunteering until their application is approved and license renewed.

Please allow extra time if you need to complete fingerprinting for a background check. If you do, instructions will be emailed to you once you complete an application.

EMS Provider Renewal Instructions

You will receive an email when your application has been processed, and your license renewed.

EMS Providers can also log into their eLicense account and check the status of their license expiration date. Processed applications will display a new expiration date of June 30, 20XX.

You can print a copy of your EMS license by clicking ***Generate Card*** on your eLicense account dashboard.
