- (Summer/fall 2025) LPHA process measures workgroups including LPHA volunteers discuss strengthening process measures for 2025-2027 biennium.

August 2025

- **All-Hazards Preparedness Plan** (submit to LPHA's Regional Emergency Coordinator in HSPR)
