

**Low Income Housing Tax Credit
Program Oregon Approved Market
Analysts Updated October 24, 2025**

The State of Oregon has compiled this list based upon amendments to Section 42 of the Internal Revenue Code requiring a comprehensive market analysis of the housing demand of the low-income individuals and households in the areas served by each low income housing tax credit project. The analysis must be performed at the developer's expense by a disinterested third party approved by the allocating agency prior to the project receiving an allocation of Low Income Housing Tax Credits.

The compilation of this list does not imply that the State of Oregon or the Oregon Department of Housing and Community Services endorses or recommends any particular market analyst, nor does it imply the selection of any analyst so listed is any guarantee of receipt of funding or project feasibility.
